- **B.** <u>426 Hillside Avenue.</u> A public hearing for discussion, consideration and recommendations regarding a request for approval of variations from Glen Ellyn Zoning Code, Section 10-4-1(N)1 to allow the construction of a second floor dormer addition to a house with a front yard setback of 15.3 feet in lieu of the minimum required front yard setback of 25 feet, and Section 10-4-1(N)3 to allow the construction of a second floor dormer addition to a house with a corner side yard setback of 11.5 feet in lieu of the minimum required corner side yard setback of 20 feet.
